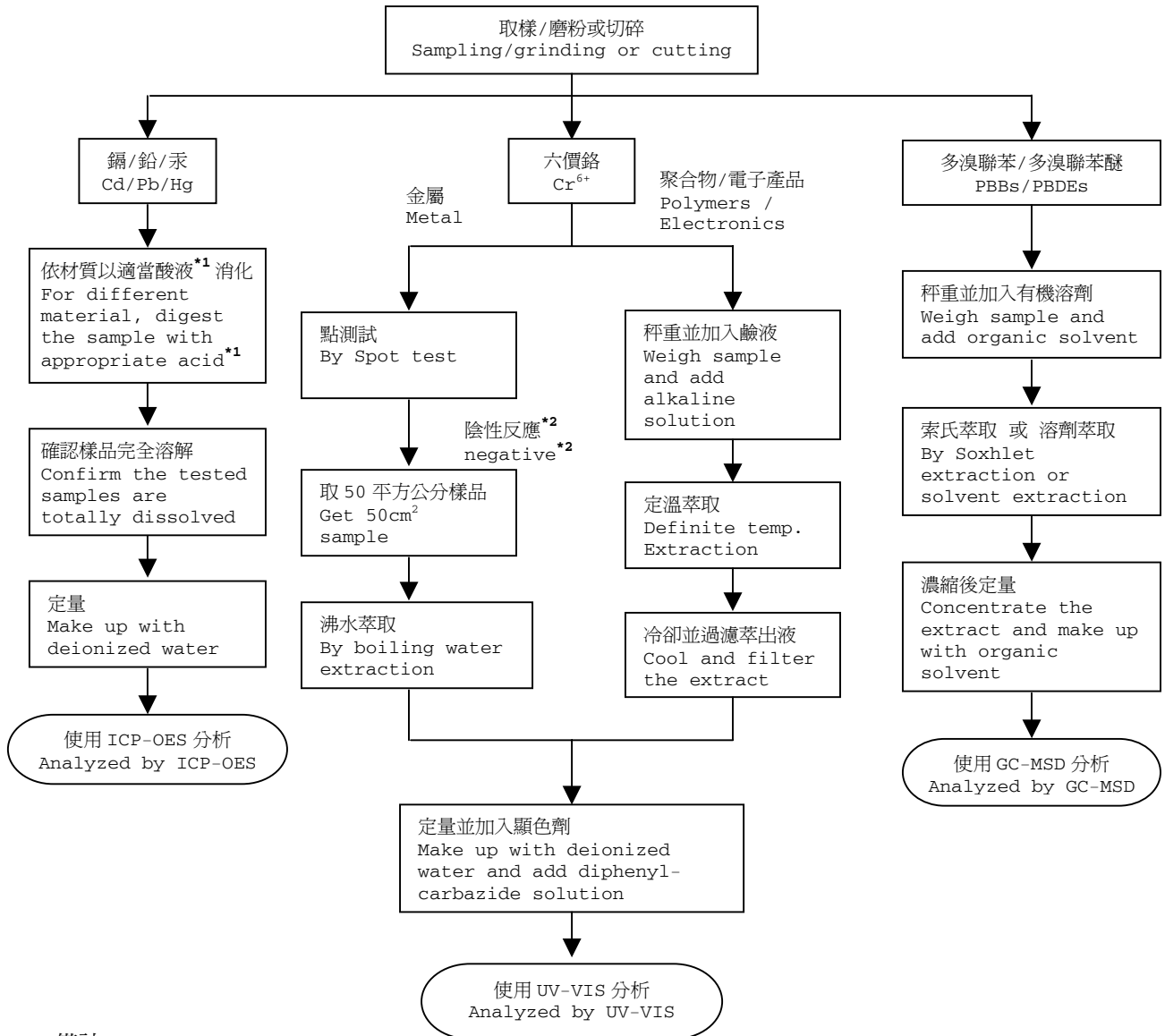

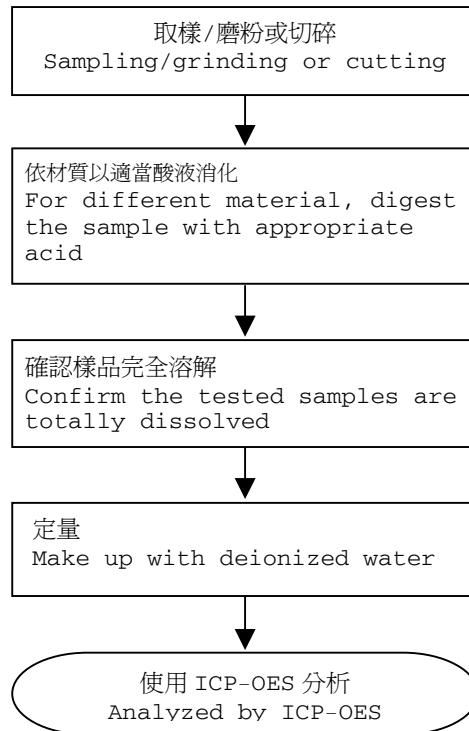

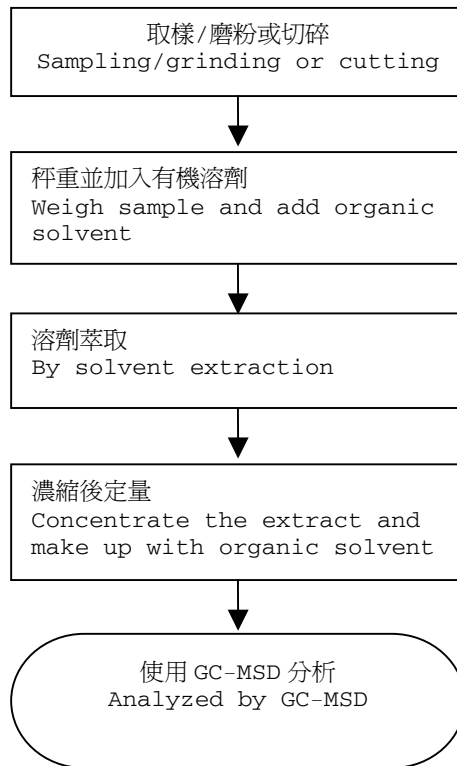

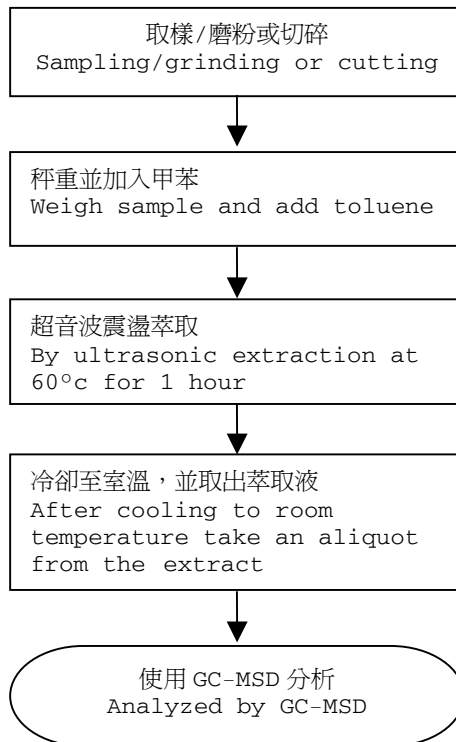

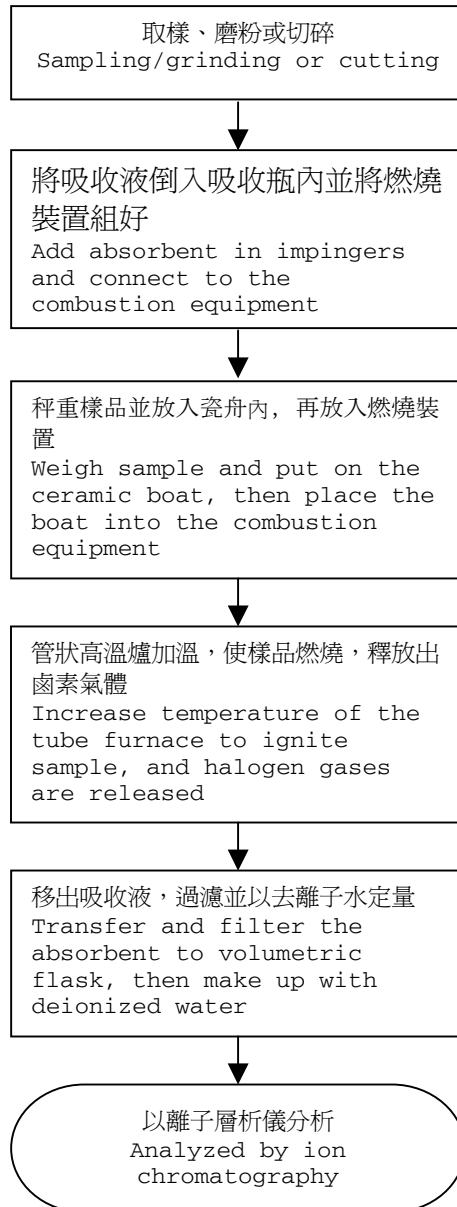

Test For Halogen Content 鹵素測試流程圖

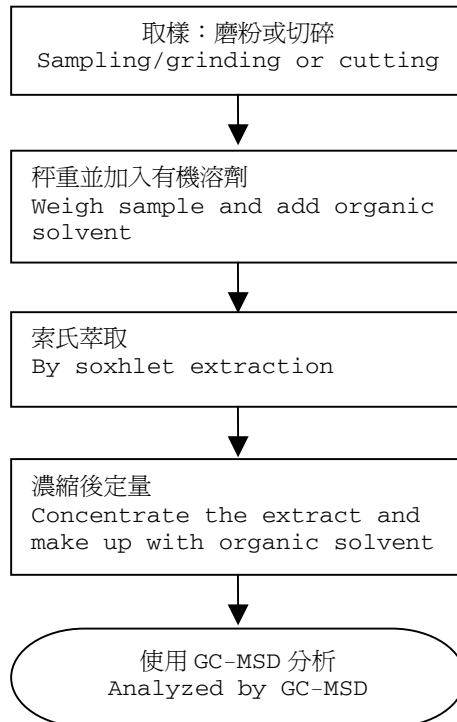

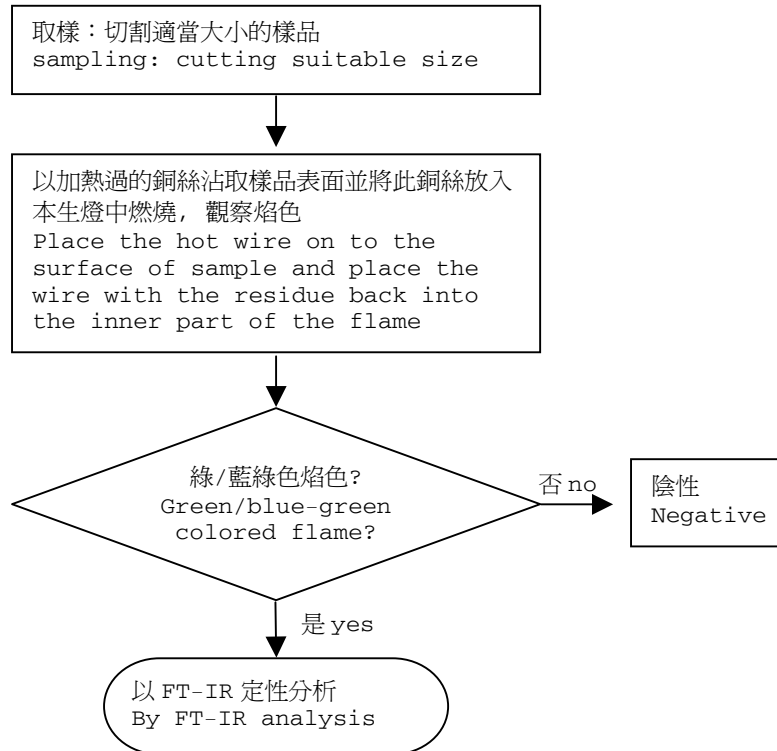
Test For TBBPA Contents 四溴雙酚-A 測試流程圖

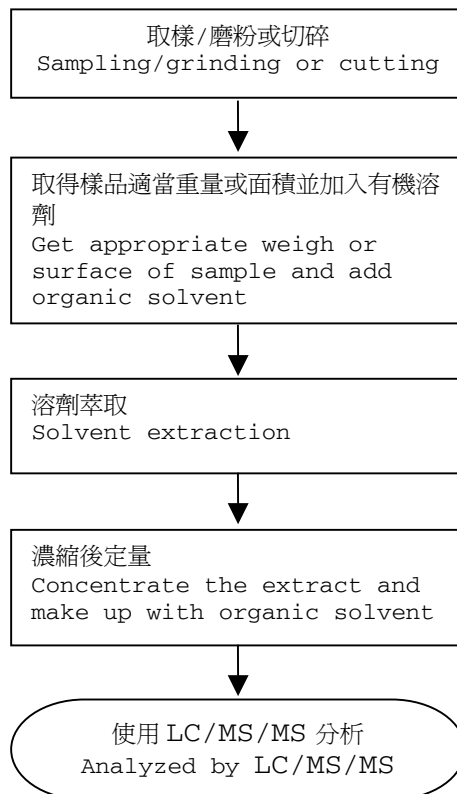
Test For Polyvinyl Chloride (PVC) 聚氯乙烯和聚氯乙烯混合物測試流程圖
